Finalists must be in the top 15 of a class in order to enter that class for the finals (after members are removed that did not qualify/enter for the finals). A finalist does NOT have to enter in that particular class at least 8 times to enter at the finals. Anyone that has entered at least 8 shows as a member may enter the Open 5D - even if they have not entered this class during the regular show year. A finalist may enter multiple horses in the Open 5D (unique horse/rider combinations). All are encouraged to enter the Open 5D - there will be \$1,000 added money and awards to Top 5 Average for every division at the Finals. Entry fees include 2 go-rounds and an average payout.
